COMPETITORS AND GROOMS

Each foreign national federation bears the cost of the travel and accommodation (hotel, meals, etc...) of her representatives. The booking for hotel, rooms has to be done and paid by the competitors.

HORSES

French and foreign horses will be accommodated in dismantling boxes on the competition area from Wednesday 21 April 14 p.m. to Monday 26 April.(littered boxes).

One bundle of straw will be given per horse and per day. Any other kind of meal and / or stable litter (shaving) will be delivered upon request made with the final entries and invoiced in addition.

If riders have stallions, they will have to let the organizer know about it when they send their entries. The stallions will be put in a separate row of boxes.

ADVERTISING AND PUBLICITY ON COMPETITORS AND HORSES

The competitors are authorised to carry the logo of their personal sponsor on their saddle-cloth in accordance with art. 136.

2. **VETERINARY ASPECTS "A"** (in accordance with vet. Regs. 8th edition, 1st January 2002) VETERINARY EXAMINATIONS, INSPECTIONS AND PASSPORT CONTROLS

These tests will be carried in accordance with Veterinarian Regulations Art 1011, 9th Edition, 1st January 2002 and the Jumping Rules for Jumping Events Annex VII, 21st edition 1st January 2003.

Art. 139.1

« Every horse entered for any competition at CSNs, CSI* in a foreign country, and all horses entered for other CSI**/****/*****/*****, Championships, Regional and Olympic Games, whether at home or in foreign countries, must have an official valid F.E.I. passport or a national passport approved by the FEI accompanied by an FEI Recognition Card as a means of identification and to establish ownership»

Art. 139.2

« Horses taking part in CSNs in their own country are not required to have such a passport as in mentioned in paragraph 1. All such horses must be properly registered and identifiable by diagram. Unless there is no national requirement for equine influenza vaccination in the host country and in the country of origin, all horses must have a valid vaccination certificate. »

EQUINE INFLUENZA VACCINATION, Vet. Regs. App. VI.

All horses and ponies for which an FEI passport or of a national passport validated by the F.E.I. has been issued, must have the vaccination section endorsed by a veterinary stating that it has received two injections for primary vaccination against equine influenza, given no less than 21 days and no more than 92 days apart. In addition, a booster injection must be recorded as having been given within each succeeding 12 months, subsequent to the second injection of the primary vaccination. None of these injections must have been given within the preceding 7 days, including the day of the competition or of entry into the event stable.

The above rules are the minimum requirement for influenza vaccination. Both primary and first and subsequent booster injections should be given according to the manufacturer's instructions, which will fall within the stipulation of the FEI ruling. In many cases booster injections are recommended by the manufacturers and by National Veterinary Authorities/Regulatory Authorities at interval more frequent than 12 months.

SAMPLINGS FOR PROHIBITED SUBSTANCES

Vet. Regulations Chap.5 and 6, Ann. 3

Regular sampling is carried out in CCI**/****, CSI**/****/*****, CIOs, World Cup Qualifiers and Finals, Championships and Games, whereas at other CIs sampling is recommended. In CICs**/****, the number of horses tested is at discretion of the Testing Veterinarian/veterinary Delegate. However, a minimum of three is recommended (Art.VR 1017.4)

Special guidelines are applicable for events covered by the FEI Medication Control Programme (Groupe I & II only)

MEDICATION CONTROL PROGRAM (ONLY IN THE GROUPS 1 AND 2)

The Organising Committees of FEI events within Groups I & II are advised to charge competitors the equivalent of CHF 12.50 per horse per event as a contribution towards the cost of the MCP programme.

SANITARY CONDITIONS AT THE HORSES IMPORT

Competitors will hold a valid veterinary certificate, good for their country of origin, and certifying that international transit veterinarian rules have been respected.

If these conditions are not respected penalties will be imposed on competitors or on their representatives.

NFs holding an international event in their country should inform their national veterinary authority and their customs authority at least four weeks prior the event. They should request every facility to assist the movement of horses accompanied by FEI passports and the necessary veterinary certification at frontier crossing points into and out of their countries(Vet. Regs. Art.1004.2)

Entries shall be declared to the CFE by post or by minitel no later than 12 April **before 12.00 am**

Entries amount per horse : 240 € (Box included by horse after the veterinary control- 92 € will be paid for horses no admitted to veterinary control)

Paid in cash on the place of event for foreign competitors when arriving.

This amount includes CHF 12.50 per horse and per competition for the participation at the International Equestrian Federation Medication Control Program.

If riders have stallions, they will have to let the organizers know about it when they send their entries. The stallions will be put in a separate row of boxes.

At the border, all foreign competitors taking part in the International Jumping in DIJON, must be in possession of the certificate delivered by the organising committee, with the description of each horse (or be sent with the nominated entries).

On entering the French territory, horses will be covered by a temporary admission permit, on production of the above mentioned permit and of the requested temporary import documents, they shall be exempted from having to pay a deposit.

The custom clearance should be made at the border.

NB: Custom formalities are at the competitors' expenses.

XI - MISCELLANEOUS

OBJECTIONS-COMPLAINTS (Art. 168-167)

To be valid, all claims must be written and a guarantee of 150 CHF must be enclosed (FEI rules).

DOCTOR, VETERINARIAN, FARRIER

Medical and veterinary assistance, as well as farriery services will be paid by the owners, riders, or concerned persons. The Organising Committee will not intervene in those settlements.

INSURANCES

All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.

EVENT'S ORGANISATION (Art. 114 + 115)

In exceptional circumstances, together with the approval of the team masters and ground juries, the organizer committee reserve the right to modify the schedule in order to clarify any matters or matters arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all competitors and officials, as soon as possible, and they must be reported to the General Secretary by the Foreign Judge.

ADMISSION AUTORIZATION FOR THE EVENT

In order to give them all the necessary tickets and badges for the event, the owner (whose name has been given with the final entries of their horses) the riders and their grooms will have to give imperatively their name, first name and function at the secretariat.

DEDUCTIONS FOR PRIZE MONEY

In accordance with Art. 130.2 of the « Finance act » for 1990, which modifies the Art. 182.B of the General Code of Taxes, submit the wages given, from the first of January 1990, to people living outside France for artistic or sportive performances, supplied or used in France to a deduction at the specific source of 15 % will all proper reserves of International Conventions.

STABLE SECURITY/STEWARDSHIP AT INTERNATIONAL EVENTS(art .1005.2.5)

1.Access to stable Area

For an optimal stable security, the stables must be completely enclosed within a suitably restrictive perimeter (stable area) which will act both as a deterrent to the admission of unauthorised persons and to the exit of horses. The area must be sufficiently large to allow horses to be evacuated from the stables in an emergency, but still remain within the confines of the perimeter. However, several disciplines allow in specific situations a lower level of stable security (see discipline rules)

Whenever possible the stable area must include stable-lorries, caravans, etc., should not be permitted within the area unless specifically needed as accommodation for horses and/or grooms.

Access to stables must be limited to those persons indicated in VRs Art. 1005.2.5.2. It is essential that the official issuing authorised access be a responsible person of seniority within the Organising Committee.

2.Control of access

A control system must operate at all entrance gates so that there is an efficient and reliable method of identifying those who enter and leave the stable area at any time.

Extra vigilance must be used in establishing the identity of persons and reasons for entering the stables during the night.

3.Stewarding of stable area

At least one stable steward directly responsible to the chief steward must be present or readily available in the vicinity of the stable area 24 hours a day during the entire duration of the event. Deputies as required may assist him. The steward/deputies must regularly patrol the stable area without establishing any

predetermined pattern, to discourage any form of illegal practice or abuses to horses. Any misdemeanours must immediately be reported to the stable steward who must, in turn, report to the Chief Steward. The duty of the stewards is therefore to safeguard the welfare of the horses and to prevent any form of illegal practices.

4.Grooms

It is appreciated that grooms wish to remain with their horses during the night. Only grooms duly registered with the OC are permitted to do so.

The person Responsible must ensure that his/her grooms, or any other persons with access to his/her horses are familiar with the security and stewarding procedures operating at the event attended.

5.Movement throughout event ground

Movement of horses between the stables, practice, grazing and main area must be strictly controlled. The optimum layout for Jumping and Dressage disciplines is attached. It is appreciated that flexibility will be required depending on the requirements of other disciplines

6.Stewarding of practice arena

The Chief Steward must ensure that each practice arena is adequately stewarded at all times that it/they are officially open. He must also ensure that all practice arena are subject to random control when they are officially closed.

7.Grazing area

It is recommended that a grazing area be provided at all outdoor events and that this be subject to random control.

The foreign Judge/TD at events will be specifically asked to check that relevant requirements are met, as reasonably as can be expected depending on the discipline, and to clearly indicate any shortfalls, following which consideration may be given to altering the category of the event in future.

II – WELFARE OF THE HORSE

1. In all equestrian sports, the horse must be considered paramount.
2. The well-being of the horse shall be above the demands of breeders, trainers, riders, owners, dealers, organisers, sponsors or officials.
3. All handling and veterinary treatment must ensure the health and welfare of the horse.
4. The highest standards of nutrition, health, sanitation and safety shall be encouraged and maintained at all times.
5. Adequate provision must be made for ventilation, feeding, watering and maintaining a healthy environment during transportation.
6. Emphasis should be placed on increasing education in training and equestrian practices and on promoting scientific studies in equine health.
7. In the interests of the horse, the fitness and competence of the rider shall be regarded as essential.
8. All riding and training methods must take account of the horse as a living entity and must not include any technique considered by the FEI to be abusive.
9. National Federations should establish adequate controls so that all persons and bodies under their jurisdiction respect the welfare of the horse.
10. The national and international Rules and Regulations in equestrian sport regarding the health and welfare of the horse must be adhered to not only during national and international events, but also in training. Competition. Rules and Regulations shall be continually reviewed to ensure such welfare.
